Course Description/Objectives:

The 30-hour Broker Post License course is required by all newly licensed brokers prior to their first license renewal. The Broker Post License Topics 15- hour course combined with the Broker Post License Applied Real Estate Practices Interactive 15-hour course will satisfy the 30-hour requirement. The Broker Post License Topics course covers License Law, State/Federal Laws, Agency and Real Estate Transactions. The Broker Post Applied Real Estate Practices is an interactive course that covers the practical application of those topics.

Post-Licensing Requirements

1. Brokers first licensed between 2/1/16 & 1/31/18 are required to complete a 30-hour post-license course and pass a final exam prior to their first license renewal.
2. Those taking the 30 hour broker post-license course during their first renewal cycle are not required to complete any additional continuing education during that cycle.
3. Attendance is required for all sessions of class.
4. Pass final 90 minute exam on the last day of class with a score of 75% or higher.
